



IMPACT ACT OF 2014 Nursing Home Compare

Change	Description
Nationwide Focused Survey Inspections	1/15, CMS and states will implement to enable better verification of staffing and quality measures
Payroll-Based Staff Reporting	Staffing major quality factor; ACA not implemented yet
Additional Quality Measures	1/15 use of antipsychotic drugs will be measured, plus more coming
Timely & Complete Data Inspection	ACA requires states to maintain website and to submit timely survey and certification information for inclusion
Improving Scoring Methodology	Place more emphasis on verified data (as opposed to self-reporting)
